Return to School

This afternoon Governor Lamont and the Commissioner of Education Dr. Cardona in collaboration with DPH announced an overview of the state's guidance for the reopening of schools in Connecticut in the fall which includes the following five health and safety guidance protocols and infection mitigation strategies:

- Maximizing social distancing
- Frequent handwashing/use of hand sanitizer
- Face coverings that completely cover the nose and mouth for all
- Enhanced cleaning/disinfection of the buildings
- Utilizing cohorts in grades K-8

Commissioner Cardona shared with superintendents on a call today that the state will continue to monitor the COVID-19 data and adjust the guidelines as needed. Everything, of course, is subject to change as the pandemic evolves.

As a result of the current guidelines, we will be working with our Return to School Committees comprised of administrators, teachers, and staff during the month of July to plan for all students and staff to return to school on Thursday, August 27th. The work of the committees will be to review all the guidance and design a detailed plan that includes, but is not limited to: schedules, health and safety, high-quality teaching and learning, social-emotional needs and issues of equity, and the use of technology to support our instructional programs. We will also continue to consult with Bolton's emergency management team comprised of town and school officials, the local health district director, as well as fire and police representatives to ensure that we are aligned with the state's guidance.
